Rules & Regulations :

1. Entries will strictly not be returned if entry fee is not received. New works will be encouraged.
2. Each author may enter 4 colour slides (5x5 cm only) per section and 4 prints minimum size 10"x12" maximum size 16"x20". Digital files should be of 1024x768 pixels for judging in a folder titled "4Judging". Another folder titled "4 Reproduction" should contain same files at 300 DPI with 10x15 inch image size.
3. An Excellent Colour Catalogue is promised to every entrant, containing more than 150 reproductions.
4. 25 to 30% entries will be accepted. Judging will be by YES/NO system. Permission to reproduce entries, without payment, in catalogue or for publicity of the salon is assumed unless specifically denied. ***
5. Awards and acceptances in this salon will be counted towards Distinctions, Star Ratings, Who's Who of all photographic bodies recognizing this salon. Judges decision is final and binding to all, they may withhold any announced award.

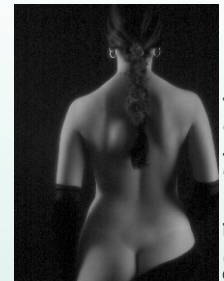

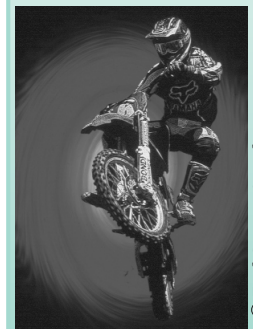
