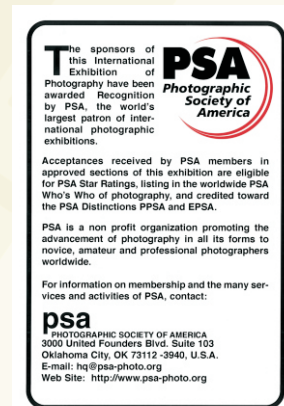

5. Awards and acceptances in this salon will be counted towards Distinctions, Star Ratings, Who's Who of all photographic bodies recognizing this salon. Judges decision is final and binding to all, they may withhold any announced award.
