Entry Conditions:

- 1) The exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to exhibition rules and conditions. Entry is not limited to images created and or modified digitally. Images may also be acquired and/or modified traditionally and then scanned.
- 2) A maximum of **four (4)** images (*digital only*) can be submitted to PSNY for each section. Each image must have a unique title. Once an image has been accepted in a PSA Recognized exhibition, that same image, or a like "in camera" or a "reproduction" duplicate of that image:
 - i. **May not** be re-entered in any section of the same Division in that exhibition regardless of media, format, or title.
 - ii. **May not** be re-titled for entry in any other PSA Recognized exhibition.
- 3) The images file size is 1024 pixels on the horizontal dimension and 768 on the vertical dimension. Images must be converted and tagged with sRGB color profile, and must be in 8-bit.jpg format. All images must be rotated as intended to be viewed. The image size should not exceed 1MB.
- 4) Please use the following format to name your JPG image files:

Surname-X-####-YZ.jpg

Surname is your Family name. "X" is the first character (Initial) in your given name.

is the last four digits of your phone number.

Y is the Section letter (A,B) & Z is the image number (1-4) of the entry.

Example:

The following four images were submitted in Section Color Open A, by Ken Lee, Phone No. 212-888-1234

****IMPORTANT** The images must be submitted as electronic files together with the entry form by upload at (<http://www.psnysusa.org>). No CDs will be accepted.**

- 5) A listing of acceptances and awards will be posted on the internet at the website www.psnysusa.org for a minimum of three months. CD catalog will also be available on-line for entrants to download.
- 6) Entry Fee is: US\$12.00 for one section; US\$20.00 for 2 sections.
Entry Fee can be paid by PayPal via Internet in USD, PSNY PayPal account Joseph Wong, (joiwong@verizon.net).
(Please add extra US\$1.00 for entry fee if paid by PayPal)

In case of foreign exchange difficulties, 40 International Reply Coupons must be enclosed to take the place of the entry fee.

Entry fee must be received to qualify images to be judged. Images with no entry fee will not be judged.

ENTRY FORM: The entry form is available at the website <http://www.psnysusa.org> and must be submitted electronically using the submit button together with the images. Instructions for filling out the entry form are included on the website. A list of all the entries received will be published on the Exhibition website. The status of the entry fee and the files received will be listed. The list will be updated weekly. Please check the status of your entries on the website about a week after sending.

- 7) PSNY will adhere to the recommended practices of PSA and FIAP. All accepted prints will be entered into the "Who's Who" of PSA. <http://www.psa-photo.org>. Acceptances received by PSA members are eligible for PSA Star Rating in the CPID division and credited toward the following PSA Distinctions PPSA, EPSA, MPSA, GMPSA.

- 8) Judging will be done by projecting images on a screen with an electronic projector at a resolution of 1024 X 768 set to 16.7 million colors. In each section the entrant's four images will be distributed throughout four rounds of judging.
- 9) Entries must originate as photographs (image-captured of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability for any misuse of copyright. Image may be altered, either electronically or otherwise by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates subject to divisional restrictions. All final work must be on photographic film or on electronic file, or on photographic or electronic print material, mounting excepted.
- 10) By submitting his/her work, it is understood that the author accepts the rules and regulations. The entrant must be the owner of all rights of the submitted works.
