The Photographic Society of America (PSA) supports a system of recognized photo competitions for photographers world-wide. In these pages are PSA-recognized exhibitions which conform to the standards of the Society (Consolidated Exhibition Standards: www.PSA-photo.org/ces2006). The exhibitions are categorized by technique and subject interest with the most current closing dates in each category listed first.

How to Use the Exhibitions Listings

The following are the listings of upcoming PSA-recognized international exhibitions. The dates in **bold type** under each division heading are the closing dates for entries to that section of the exhibition.

The exhibition's name is listed in CAPITAL letters.

The person listed is the one to contact for an entry form and other information. The entry fee is listed next. This is followed by email address and web site information, as may be available. The entry fee is listed last.

Only PSA members can apply their exhibition acceptances toward Star Ratings, and only acceptances received in exhibitions listed in the *PSA Journal* are valid. Stars (colored metal tabs that can be attached to your PSA membership button) are awarded when you have a certain number of acceptances, with each division having its own requirements. For these requirements and other information, write to the appropriate Star Ratings director—names are listed by division under "Services for Individuals" in the quarterly "Services & Activities" section. Star Ratings listings are also published quarterly in the *PSA Journal*.

Every May the *PSA Journal* publishes "Who's Who," a listing of all exhibitors who have met or exceeded individual division acceptance requirements during the previous year.

PSA Recommendation

PSA encourages sponsors of international exhibitions to select the most qualified individuals for judges. The Society does not establish criteria for choosing judges, nor does it impose rules or standards regarding the quality or aesthetics of the photographs selected.

How to Have Your Exhibition Listed

If you'd like to have your exhibition listed on these pages, contact the exhibition standards director for each division that will be a part of your exhibition. The exhibition standards directors, who are listed under the division headings, recognize individual exhibitions and provide these listings.

Notice to Exhibitions

All exhibitions, including those in circuits, that are recognized for listing in the *PSA Journal*, and whose acceptances thereby become eligible for Star Ratings and Who's Who, will be expected to pay the fee of \$20 per section, per judging, to the appropriate division.

Sponsors who qualify to award PSA medals (those who have run an exemplary exhibition a previous year) will be given a Best of Show gold medal for each section at no extra charge and may purchase additional medals and HM ribbons for the same section(s) if the division authorizes one. Exhibitions that are recognized, but do not qualify to award the medals, will be listed in the *PSA Journal* upon payment of the fee. The amount has not changed, although in the past it was treated as an optional medal purchase rather than a required listing fee. This was passed by vote of the Executive Committee of PSA on April 24, 1999, to ensure that all exhibitions share equally in the costs of granting divisional recognition.

Manuscript Mechanics

Attention all Contributors to the *PSA Journal*

For over 70 years, PSAers have been writing articles for the *PSA Journal*. Tremendous changes have taken place in both the photographic industry and in the printing industry. While many of the key elements of preparing a manuscript for publication are the same, new technology has brought some new requirements.

The current method for submission of material for the *Journal* is via e-mail. Simply attach your word processor file to the e-mail and send it to the *PSA Journal* Editor at editor@psa-photo.org. If your e-mail program does not allow you to send attachments, copy the text from your word processing program directly into the body of the e-mail. Providing a digital file for your typewritten text allows immediate use of your document because it does not have to be re-typed and is a very efficient way to ensure that your submission is exactly as you typed it (with the exception of any editorial changes deemed necessary). If you do not personally have e-mail, please ask for help from a friend or relative to send the submission to the Editor for you, after you are satisfied it was typed accurately. Contact the Editor or the PSA Publications Vice President if you have trouble finding a typist.

Don't use all capital letters. When you type your article, use regular type, not script, and use upper and lower case letters. It is no longer necessary to double-space the text or leave wide margins. Do not do so. Please do not justify the right-hand margin.

When sending accompanying photos, prints or slides are preferred so that the images can be scanned

according to the size at which they will be printed and to ensure that the brightness and color levels are based on the settings our commercial printer uses. Send more images than can be used: the Editor can select suitable images. Also, we will know at the time of scanning whether an image needs to be scanned as a grayscale or color image, as that affects the output too. We cannot use glass-mounted slides.

You may also submit high resolution (300 dpi) digital files. If you are planning to send digital images, please contact the *PSA Journal* Editor for specific requirements.

Please meet our deadlines. We have a two-month lead time for all scheduled material. All non-scheduled submissions are used when the Editor can work them into issues. If you are submitting an article for a particular issue, your finished article needs to be into the *Journal* editor 60 days before the first day of the issue month. We do not write articles from your notes; we use your prepared document, subject to editing.

If you have had an article on file at the *PSA Journal* office for a long time, it is possible we have just not had the space, or we needed to use other articles first to meet PSA guidelines, emphasize a theme, or balance the content. We will, however, return it upon your request. Occasionally some material never works into the magazine and has to be returned.

We appreciate all of the PSA authors. Thank you for making your mark for the advancement of photography and helping others learn from your experience and expertise.
