Exhibition Catalog Mailing Requirements

The Consolidated Exhibition Standards (CES) requires that one copy of an exhibition's catalog be sent (via First Class mail from North America exhibitions; via Air Mail from Overseas exhibitions) no later than the approved catalog mailing date. If, for example, your exhibition has a color slide and color print section, then you send catalogs to the people show in the color slide page and the pictorial print page.

Also, two copies must be sent to Star Ratings Director: Carol Bailey, FPSA, EPSA, 6995-A Franktown Road, Carson City NV 89704, USA - E-Mail: bcarolb@pyramid.net

There is a separate page for the names, addresses and emails of each person to whom a catalog must be sent for each section (color slides, nature slides/prints, photo travel slides/prints, photojournalism slides/prints and pictorial prints: large, small and commercial) which has PSA approval.

Specific requirements per the Consolidated Exhibition Standards are:

- Exhibition name and year must be on the cover.
- PSA Recognition Statement must be printed.

If you go to <http://www.psaexhibitionstandards.com/PSA-Ad.php> and click on any division, you will find a vertical version as well as a horizontal version of the recognition statement. Download and size to meet your needs.

- PSA Recognition Statement must be as large as that of any other international photographic organization. See item 9a.
- Names of judges in each section and/or category must be listed.
- Listing of Awards must be included and the listing must be separated by class, etc. List must precede acceptance listing.
- List of accepted exhibitors must be in alphabetical order.
- Sections must be in alphabetical order: Color Projected Images, EID, Nature Digital, Nature Prints, Nature Slides, Photo Travel Digital, Photo Travel Prints, Photo Travel Slides, PJ Digital, PJ Prints, PJ Slides, Pictorial Prints and Stereo Digital, Stereo Prints and Stereo Slides.
- Catalog must be mailed to exhibitors by approved mailing date.
- Font and type size must be legible to the average reader. Personally, I recommend a 9 point or larger font.
- An online version or one sent as a PDF file to exhibitors must have exhibition name and year on each page.
